Weight: Three Year Olds, 122 lbs.; Older, 124 lbs. Fillies and Mares allowed 3 lbs. Non-winners of three races for an allowance purse, or for a starter or claiming price of \$40,000 or greater since January 1, 2016, allowed 2 lbs.; two races for an allowance purse, or for a starter or claiming price of \$32,000 or greater since January 1, 2016, allowed 4 lbs.; a race for an allowance purse, or for a starter or claiming price of \$32,000 or greater since January 1, 2016, allowed 6 lbs. If deemed inadvisable to run on the turf, this race may be transferred to the main course to be run at five furlongs. \$1,400 to enter and \$750 to start. Maximum of 14 starters. Supplemental Nominations may be made at time of entry at a cost of \$2,500. Nominations close Sunday, November 6, 2016.
