FILLIES AND MARES, THREE YEARS OLD AND UPWARD, WHICH HAVE STARTED FOR A CLAIMING PRICE OF \$25,000 OR LESS SINCE JANUARY 1, 2015 \$125,000 guaranteed, of which \$68,750 is awarded to first, \$25,000 to second, \$12,500 to third, \$6,250 to fourth, and \$1,250 to all other finishers. Three Year Olds, 121 lbs.; Older, 124 lbs. Non-winners of three races for an allowance purse, or for a starter or claiming price of \$40,000 or greater since January 1, 2016, allowed 2 lbs.; two races for an allowance purse, or for a starter or claiming price of \$32,000 or greater since January 1, 2016, allowed 4 lbs.; a race for an allowance purse, or for a starter or claiming price of \$32,000 or greater since January 1, 2016, allowed 6 lbs. If deemed inadvisable to run on the turf, this race may be transferred to the main course to be run at One and One-Sixteenth Miles. \$1,600 to enter and \$900 to start. Maximum of 14 starters. Supplemental Nominations may be made at time of entry at a cost of \$3,000. Nominations close Sunday, November 6, 2016.
