FOR HORSES WHICH HAVE STARTED FOR A CLAIMING PRICE OF \$16,000 OR LESS IN 2021-22 Age: Three-Year-Olds & Up Distance: Seven Furlongs (7.0 f) Purse: \$125,000 guaranteed plus \$15,000 KTDF. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights: Three-Year-Olds 124 lbs. Four-Year-Olds and Older 126 lbs. Fillies and Mares allowed 3 lbs. Non-winners of a stakes race in 2022 allowed 2 lbs.; of a stakes race in 2021 or two allowance, starter races for \$16,000 or greater, or claiming races of \$20,000 or greater since June 1, 2022, allowed 4 lbs.; non-winners of such a race since then, allowed 6 lbs. Preference given to stakes winners in 2021-22, then by highest earnings in 2021-22. Late Request for Eligibility after October 22, and up to time of entry must be accompanied by a administrative fee of \$1,000 at or before time of entry on Wednesday, November 9, 2022.
