FOR FILLIES AND MARES WHICH HAVE STARTED FOR A CLAIMING PRICE OF \$25,000 OR LESS IN 2021-22 Age: Three-Year-Olds & Up Distance: One and One-Sixteenth Miles (8.5 f) on the turf Purse: 150,000 guaranteed plus \$20,000 KTDF. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights: Three-Year-Olds 124 lbs. Four-Year-Olds and Older 126 lbs. Non-winners of a stakes race in 2022 allowed 2 lbs.; of a stakes race in 2021 or two allowance, starter races for \$25,000 or greater, or claiming races of \$30,000 or greater since June 1, 2022, allowed 4 lbs.; non-winners of such a race since then, allowed 6 lbs. Preference given to graded stakes winners, then graded stakes placed, then stakes winners in 2021-22, then by highest earnings in 2021-22. Management reserves the right to transfer this race to the main track if it is considered inadvisable. Late Request for Eligibility after October 22, and up to time of entry must be accompanied by a administrative fee of \$1,000 at or before time of entry on Wednesday, November 9, 2022.
